Mr. Pfenniger is an experienced executive with significant experience in the life science, healthcare, and education fields. He is also an accomplished lawyer who began his career in public accounting.

Most recently Mr. Pfenniger served as Interim Chief Executive Officer of Vein Clinics of America, Inc. VCA is the largest medical group in the United States specializing exclusively in the treatment of vein disease. Prior thereto, Mr. Pfenniger served as the Interim Chief Executive Officer of IntegraMed America, Inc. which operates the largest network of fertility centers in North America.

Previously, Mr. Pfenniger served as the Chairman of the Board of Directors and President and Chief Executive Officer of Continucare Corporation from 2003 until its acquisition by Metropolitan Health, Inc. in 2011. Continucare was a provider of primary care physician services. Through its own medical centers and a network of independent physician affiliates, Continucare provided medical services to over 40,000 patients in Florida. At Continucare, Mr. Pfenniger directed the turnaround and subsequent growth and expansion of the business. At the time Mr. Pfenniger joined Continucare the business had experienced declining revenues, operating losses, and negative cash flow for the previous five years. During his tenure as CEO, performance improved each year with annual revenues increasing approximately three-fold, and the company posting higher profits and increased cash flow each year.

Prior to joining Continucare, Mr. Pfenniger served as Chief Executive Officer and Vice Chairman of Whitman Education Group, Inc. for six years until Whitman Education was acquired by Career Education Corporation in 2003. Whitman Education was a leading provider of career-oriented higher education. As Chief Executive Officer, Mr. Pfenniger oversaw the turnaround and growth of Whitman Education's business. During his tenure, Whitman Education's annual revenues increased approximately 135% and profitability improved significantly.

Prior to his tenure at Whitman Education, Mr. Pfenniger was an executive officer of IV AX Corporation, serving as its Chief Operating Officer from 1994 to 1997 and as its Senior Vice President- Legal Affairs and General Counsel from 1989 to 1994.

IVAX Corporation was a multi-national pharmaceutical company that was acquired by TEVA Pharmaceuticals in 2006.

Before joining IV AX, Mr. Pfenniger was engaged in the private practice of law in Miami, Florida with his practice focused primarily on business transactions. He began his career in accounting, as a certified public accountant working for Price Waterhouse.
